The HCMUNRE and VMU shall be collectively hereinafter referred to as the "Parties".

WITNESSETH:

WHEREAS HCMUNRE and VMU mutually wish to strengthen their educational and scientific research collaboration under the Marine Coastal and Delta Sustainability for Southeast Asia (MARE) project;

NOW, THEREFORE, in consideration of the mutual interests and covenants hereinafter set forth, the HCMUNRE and VMU hereto covenant and agree as follows:



Article 1: OBJECTIVE AND FRAMEWORK OF COOPERATION

This MOU is aimed to enhance the sustainability and efficiency of the MARE project among Vietnamese partners, including VMU and HCMUNRE based on the following activities:

- Exchange of students, lecturers and staff members;
- Conducting collaborative research projects, seminars and academic meetings;
- Exchange of academic materials and other information;
- Holding E-learning courses;
- Collaboration in educating BSc., MSc. and PhD.;
- Promoting other academic cooperation as mutually agreed.

The detailed conditions and expenses related to aforementioned activities shall be discussed and agreed upon in writing by the appropriate authority of each Party.

Article 2: INSTITUTIONAL APPOINTEES

Issues covered by this MOU shall be handled by the following person in charge and contact person of the parties:

a. HCMUNRE:

Article 3: MISCELLANEOUS

3.1. Duration:

The MOU is valid for a period of five (05) years from the date of signing by the representatives of both parties. If neither party gives written notice to the other at least six

(06) months prior to the expiration of this period of its desire to terminate the present MOU, this MOU shall be automatically extended.

3.2. Amendment:

This Agreement may be amended by means of common written consent of both parties and the agreed amendment shall be attached and construed as a part of this MOU.

The Parties have executed MOU in duplicate original, and each party shall keep one.
